	Application form & declarations duly signed
	Copy of your passport's data page (A4 size copy)
	Personal covering letter explaining the exact purpose of your stay in Germany
	<b>Work Contract</b> confirming conditions of your stay in Germany, including salary and social insurance payments
	<b>ZAV Application form</b> (will be filled out by the International Institute of Culinary Arts, New Delhi)
	Qualification Certificate (from International Institute of Culinary Arts, New Delhi)
	Curriculum Vitae (in tabular form)
	Proof of 6 years' work experience as a cook specialized in Indian food
	Birth certificate
	School leaving certificate
	3 passport pictures according to biometric specifications, not older than 6 months
	Demand Draft

Please prepare two identical application sets with the above-mentioned documents and bring your original certificates along. Please DO NOT staple any documents.
